NYC Department of Transportation (DOT) officials and New York City Mayor Eric Adams announced the launch of a new e-bike safety campaign on March 19. and on March 20. they called for the renewal and

expansion of the City's redlight camera program. The announcements come following a week of moped/dirt bike chaos across The Bronx.

On Thursday, March 14, after police observed "a roving band" of ATV [all-terrain vehicle] / dirt bike riders traveling in a pack in the Norwood/Bedford Park area, which they said later dispersed in different directions, an ATV rider was hospitalized following a collision with a sedan the same evening.

Meanwhile, police were searching for another dirt bike / motorcycle rider who, the

same evening, attempted to assault two cops in Norwood. Later that evening, in Morris Park, a motorcycle rider was killed in a collision with an ambulance and on Sunday, March 17, another "roving band" was witnessed in Norwood.

One person described as male has been hospitalized and is also in custody following a collision involving an ATV [all-terrain vehicle/dirt bike] and a car on Thursday evening, March 14, in Bedford Park.

Separately, in nearby Norwood, a motorcycle rider was being sought for an assault on police the same evening, and later that night, a motorcycle rider died after being hospitalized following a collision with an ambulance in Morris Park.

Police said officers had observed "a roving band," meaning a large group of motorcycles and ATVs traveling in a pack, in the vicinity of Jerome Avenue and East Mosholu Parkway in Bedford Park at 6.13 p.m. on March 14, and had put word out over the police radio. They said the group subsequently dispersed in different directions.

A police spokesperson later said, "One of the ATVs ends up at the intersection of Grand Concourse and Van Cortlandt when he sees a separate police vehicle behind him with lights and siren not activated, like no lights or siren turned on."

We asked if the police car had been in pursuit of the ATV nonetheless and the spokesperson said, "At that time, at the intersection, that police vehicle did not have lights, or a siren activated." We asked if the police vehicle had been stationary or in motion and the spokesperson said, "It came up behind the ATV at the red light and for whatever reason, I guess, he [the ATV driver] was spooked or for whatever reason, the ATV [driver] decides to run the red light."

The spokesperson continued, "At the same time, a blue 2017 Nissan sedan was approaching on Van Cortlandt, going towards Mosholu Parkway [across the Grand Concourse] which ends up colliding with that ATV and the Nissan was occupied times two." He said there was a 63-year-old male driver in the sedan along with a 20-year-old male passenger, and that both refused medical attention at the scene.

He said the driver of the ATV was transferred to St. Barnabas Hospital initially in critical condition and was reportedly later in stable condition. "He remains in police custody," the spokesperson said. "At this point, it's not an ar-

off."

rest. It's a pending investigation so we'll be updating it."

Asked if there was more than one occupant on the ATV at the time of the collision, the spokesperson said he just had a report of one occupant. After some earlier, conflicting reports about whether there had or had not been a collision, police reported that the NYPD's collision investigation squad had been called to the Bedford Park accident location.

Asked for a description of the hospitalized victim, the NYPD said he was male. "I don't have an age or anything like that, but it appears it was a male," a spokesperson said.

Earlier on Thursday evening, there had also been some separate, unconfirmed reports of a possible collision at nearby East Gun Hill Road and Bainbridge Avenue in Norwood. We asked police about this, and a spokesperson said he didn't have any record of a separate collision at that location. In the end, it transpires it was actually an assault, rather than a collision.

Meanwhile, EMS and several police vehicles were seen at Van Cortlandt Avenue and the Grand Concourse, and helicopters were seen and heard flying over the area from around 6 p.m.

One female resident who declined to be identified told *Norwood News* she saw around 20 riders on motorcycles / ATVs traveling on Paul Avenue towards

She continued, "But the other people that were on it with him kept driving, and

Asked how she felt about the incident happening in her neighborhood, the woman said, "I mean it's, I guess, it's scary because there hasn't been a lot happening in this neighborhood, I think, until recently that's making a lot of people want to move from here."

A group of motorcycles and ATV riders had been seen by *Norwood News* on Tuesday, March 12, at around 5 p.m. traveling at high speed, and breaking lights, up and down the Grand Concourse in the same general vicinity as where the collision occurred. We asked the woman if she had also seen the group. "I've seen a lot of those, yeah," she said. "They're very reckless. I mean they're very scary. All those motorcycles in general are terrifying."

We asked if she had witnessed the riders breaking the red lights. The woman said, "Um, I don't think I've paid attention to that but they're very reckless, and there's always usually like a group, right? Yeah, I have seen them on like Jerome [Avenue] over there."

CHAM officials say Certified Child

Life Specialists (CCLS) assist children through medical play, helping them understand their illness, cope with procedures, and achieve their health goals. They said Polly is kicking off her new job at CHAM during Child Life Month, which is dedicated to recognizing and celebrating the vital role CCLS play in supporting young patients.

Child Life is a specialty that has evolved over the past 100 years and uses help young patients who are anxious, who are facing extended hospital stays, and who need assistance getting through tough procedures. We are delighted to welcome Polly as the newest member of the CHAM Child Life team."

CHAM officials said Polly spent the last six months in professional training with expert instructors at Canine Companies, who have provided facility dog, animals highly trained to assist health-



care professionals with specific tasks, free of charge, since 1975.

Polly comes to CHAM thanks to funds raised by former New York Ranger and current Boston Bruins defenseman, Kevin Shattenkirk, through his partnership with the Jam Kancer in the Kan Foundation.

"I've seen first-hand just how important the Child Life Specialists are to a patient's treatment during my visits to CHAM," said Shattenkirk, who previously funded staffing which enabled a playroom at CHAM to be opened and available for extended times during the day

"My wife Deanna and I jumped at the opportunity to add a four-legged member to the team," he added. "We believe Polly will have such a positive impact on every child she interacts with."

CHAM officials said Polly will be

available to "treat" patients in need of physical and emotional support, such as children recovering from surgery who need encouragement getting out of bed and walking. They said she'll also assist children who need motivation to have open conversations about difficult and stressful topics, such as eating disorders.

They said Polly will see around seven patients per day and will live with her own dedicated certified child life specialist, Katy Dessick. "Polly is a unique member of our Child Life team," said Dessick. "Few children's hospitals have facility dogs in-house to assist with patient needs. We are very grateful to Kevin Shattenkirk for making this possible, and to Canine Companions, who dedicate countless hours to training dogs like Polly to be crucial aids for people in need of extra support."

seen a group of motorcycles and ATV riders traveling at speed on the Grand Concourse in the Tremont area earlier on Thursday evening, March 14. It's unknown if it was the same group as was seen by police at Mosholu Parkway and Jerome Avenue in Bedford Park at 6.13 p.m.

Norwood News also contacted the NYPD to ask about a separate, unconfirmed report of a brick being thrown at a police officer possibly by a motorcycle rider in the Tremont area prior to the collision in Bedford Park on March 14, but were informed they had no record of this. In the end, it seems this incident actually occurred in Norwood, not Tremont.

Traffic was still being allowed pass through the Grand Concourse scene of the incident on Thursday evening, despite one section being cordoned off,

but some delays were expected. We also spoke to some other pass-

them what they knew. One woman who described herself as Mariela de ersby after the accident and asked la Fiesta (Party Mariela) said, "I live nearby so I heard the helicopters and it brings to my attention what was happening, and when I came. I just find the police." She said she didn't see what happened but understood it was an accident. She didn't see any injured people, she said.

Norwood News previously reported on a major crackdown by police on illegal scooters, motorcycles, and ATVs when the 52nd Precinct unveiled a stash of unregistered bikes they had seized in August 2022.

This week, following our recent report on the defacing of a Norwood mural allegedly by gang members, we asked readers if they or any children in their extended family have been approached about joining a gang, and how the family responded.



"I had a younger brother who joined years ago in the 2000s. Yes, he got away from it, and he turned his life around and became a teacher. I think it's a big problem for kids. I dealt with gangs too, but in the situation today, the kids are misled, and people join because of family issues or whatever the case may be, but it's not the right way to go. Even if you're down with a gang, you can always turn your life around.

"My son said they did ask him if he wanted to join [a] gang and he said, 'No.' He told me, 'Mommy, they asked me to join the gang, but I said no because you taught me well.'

"I have no children in my immediate family but if someone was asked, rather than join a gang, maybe join an Outbound Program, the Goodwill Rebound program. A lot of gang members don't like the police; maybe become a police officer. They could join the Explorer's Program or the Police Athletic League. I think gangs are a widespread problem.

"Basically, when my sons were in high school, they were approached but were able to politely decline because of their mother's influence and family values. But they have classmates that they went to school with who are gang-affiliated and the parents don't even know."

"Forced to flee in the 18th century, they settled along the Atlantic coast of Central America in the countries of Guatemala, Nicaragua, Belize, and Honduras where many continue to live today," they wrote. "In the 20th century, many began to migrate to the United States and settle in The Bronx, home to the largest Garifuna in the United States."

#### **BCC's Gould Memorial Library Wins Preservation Award**

The Gould Memorial Library, located on Bronx Community College campus, has won a 2024 Lucy G. Moses Preservation Award and its representatives will formally receive the award, bestowed by The New York Landmarks Conservancy, during a ceremony on April 10 at The Plaza Hotel in Manhattan. The ceremony attracts an audience of more than 500 every year, according to the conservancy, a private non-profit organization that has led the effort to preserve and protect New York Citv's architectural legacy for more than 50 years.

#### Woman Alleges Sexual Assault by Mayor

Lorna Beach-Mathura, a resident of Florida and former resident of Brooklyn. filed a lawsuit in the State of New York on March 18, under the Adult Survivors Act against New York City Mayor Eric Adams, citing an alleged sexual assault in 1993, when both she and Adams were employees with the Transit Bureau of the NYPD.

According to court-filed documents, having been passed over for promotion, Beach-Mathura, a Black, female NYPD employee, alleges she sought help with her career from Adams, both in his capacity as a police officer and as a leader in the NYPD Guardians Association, an organization which advocates for the rights of Black employees. Beach-Mathura, who holds a doctoral degree in educational leadership and who works in education according to her LinkedIn profile, alleges that instead of helping her, Adams allegedly asked her to perform oral sex on him after he allegedly drove her to a vacant lot.

Court papers show the lawsuit has also been filed against the NYPD Transit Bureau, the NYPD Guardians Association, and three other "unknown" entities, which are also defendants. The Adult Survivors Act is New York State legislation enacted in May 2022 which amended state law to allow alleged victims of sexual offenses for which the statute of limitations had lapsed to file civil suits for a one-year period, from November 24, 2022, to November 24, 2023. The mayor denies the allegation

Norwood News asked City Hall, the NYPD, and the City's law department, which is representing the mayor, if the NYPD Guardians Association and Transit Bureau also deny the allegations. We did not receive an immediate response.

#### Valentine Ave Alleged Drug **Traffickers Named**

Federal prosecutors have named the 16 alleged, Valentine Avenue drug traffickers referenced in the front-page story of our March 7-20, 2024, edition. Prosecutors said they are Edwin Carrasquillo, aka "Malo," Hector Hernandez, aka "Hec," Jose Hernandez, aka "Nene," aka "Little," Nathaniel Manning, aka "Tio," Damel Marcus, aka "Shank," Edward Moreno, aka "AR," Jason Rivera, aka "Colombo," Josue Vargas, aka "Leo," Juan Kuang, aka "Jo Jo," aka "Jay," aka "Blanco," Steven Santiago, aka "Swizz," Victor Mendeng, aka "Cali," Delilah Carriel, Rosemarie Sanchez, aka "Rosie," Juan Calderon, aka "Jazzo," aka "Juanito," Christopher Meadows, and Angel Villafane. They said charges were filed against the 16, who were described as members and leaders of "an armed and violent drug trafficking crew."

They said they were arrested following the execution of a search warrant on the night of March 5 and the morning of March 6 at a Valentine Avenue address located, we believe, between East 194th Street and East 196th Street, in Fordham Manor. Some or all were charged with engaging in a continuing criminal enterprise, distributing narcotics, and carrying and using firearms in connection with an armed drug trafficking operation based at Valentine Avenue in the Kingsbridge section of The Bronx for over a decade from 2012 to the present. The defendants are presumed innocent unless and until convicted in a court of law.

#### Fordham Heights: Man, 47, Shot Several Times & Dies

A 47-year-old man died following a shooting in Fordham Heights. Police said that on Saturday, March 16, at around 9.40 p.m., officers responded to 911 calls regarding a person who had been shot in front of 2311 Morris Avenue, a multistory, residential building located between Field Place and East 183rd Street.

They said upon arrival, officers observed the man with multiple gunshot wounds throughout the body, and he was removed by EMS to St. Barnabas Hospital where he was pronounced deceased. No arrests have been made and the investigation remains ongoing, police said. The deceased was identified as Alexis Ramirez of Creston Avenue in Fordham Heights.



#### Pelham Bay: 3rd Man Charged in Murder of Two Left Inside **Burning Car**

The NYPD said a third Manhattan man, aged 26, has been arrested and charged with kidnapping and murder, among other charges, after two young people were shot, execution-style, and left in a burning car on the side of a road near Pelham Bay Park in 2022. Police said Terrence White of 212 West 109th Street was arrested on March 18, at 10.30 a.m. in The Bronx.

Bronx District Attorney Darcel D. Clark said in early March that a second Manhattan man, Rahul Cuya, 24, of Baruch Drive had been charged with kidnapping and murder, among other offenses, in connection with the case. The NYPD said Cuva was arrested on March

12 in The Bronx and was arraigned the following day at Bronx Criminal Court. Cuya was remanded in custody and is due back in court in June.

The DA's office said Jahmel Sanders, 30, also of Baruch Drive, Manhattan, had previously been arraigned also in connection to the incident on March 9, 2023, and been charged with murder and kidnapping, among other offenses and that a fourth defendant, Steven Santiago, is still being sought. Sanders was due back in court in June 2023. We followed up on the status of his case with the Bronx District Attorney's Office but did not receive an immediate update.

According to the investigation, on May 16, 2022, Cuya, in conjunction with Sanders and others, allegedly kidnapped Nikki Huang, 22, and Jesse Parrilla, 22, both of Manhattan, transported them to Shore Road near Pelham Bay Park in The Bronx, where they were shot. A Honda Accord was set on fire with the victims inside it. Huang suffered bullet wounds to her head and neck and Parilla suffered bullet wounds to his head and chest. Their bodies were burned almost to ash.

According to the investigation, prior to the shootings, on May 15, 2022, at 9.30 p.m., Huang told friends who are alleged gang members that she was robbed of a purse in Manhattan and two hours later, a man was fatally shot in Manhattan. At around 1.20 a.m. on May 16, 2022, Parrilla, driving his mother's Honda Ac-

cord, was dropping off Huang near her home on the Lower East Side when the defendants allegedly grabbed him and put him in another vehicle, and one of the defendant's took the Accord.

Around 20 minutes later, Huang was lured out of her building and taken into the same Honda Accord. The victims were driven to Queens and then to The Bronx. At around 4.16 a.m., Parilla's mother's Accord was discovered in flames on Shore Road near a golf course. The defendants are presumed innocent unless and until convicted in a court of law.

#### Bronx-based NYPD Lieutenant Arrested in 49th Precinct

An off-duty member of the NYPD was arrested and charged in the confines of the 49th Precinct on Sunday, March 17. The 49th Precinct covers the northeastern portion of The Bronx, including Allerton, Morris Park, Van Nest, Pelham Parkway, Eastchester Gardens, and Pelham Gardens.

NYPD Lieutenant Edward Lawyerr, 35, was arrested and charged for driving while intoxicated and for refusal to take a breath test. Lawyerr is assigned to the 46th Precinct, which covers the neighborhoods of Fordham, University Heights, Morris Heights and Mt. Hope. He became a police officer in 2010, was promoted to sergeant in 2016 and lieutenant in 2022. He is presumed innocent unless and until convicted in a court of law.

#### Bedford Park: Trial Begins for Man Arrested after Fatal Shooting of Mother & Assault of Two Minors

The murder trial following the fatal shooting of Saida Bonilla Mejia, 40, of 226 East 203rd Street in Bedford Park began at Bronx Criminal Court on Wednesday, March 13. As reported, Rosvin A. Mejia Castillo, 37, also of 226 East 203rd Street, was arrested and charged in connection with the incident on Saturday, Feb. 10, at 12.15 p.m. at the 52nd Precinct and later appeared in court accompanied by his defense attorney.

Mejia Castillo has been charged with murder, two counts of attempted murder, three counts of assault, attempted assault, six counts of criminal possession of a weapon, and two counts of endangering the welfare of a child. Dressed in what appeared to be a beige jumpsuit and white t-shirt and receiving Spanish language translation of the proceedings through an interpreter, he pled not guilty to the charges.

Police said Bonilla Mejia was shot inside her home in the early hours of Feb. 10, following reports of an assault, and died later at Jacobi Medical Center. Two of her children, a teenager and a young child, were also shot but were reported to be in stable condition following the incident, police said. They also said the incident appeared to have been "domestic related."

The defense attorney for Mejia Castillo requested a restriction on media coverage of the trial, arguing it had the potential to influence the jury (who were not present in court on March 13). *Norwood News* argued that coverage of the trial was in the public interest and that the incident had been traumatizing for all concerned. The judge ruled in our favor.

In October 2023, Bronx Borough President Vanessa L. Gibson launched "31 Days of Action Against DV" (domestic violence) to raise awareness of the issue and the fact that the north Bronx has seen the highest rates of domestic violence in the City in recent years.

The prosecuting attorney said discovery items had been shared with the defense team. Discovery is the term used in law to describe the compulsory disclosure of relevant documents between two parties to a legal action. The prosecution requested that an existing order of protection for the two children who were victims of the shooting be extended. Her request was granted by the presiding judge.

Mejia Castillo was remanded in custody. He seemingly had

both his hands restrained behind his back while in court, with one arm freed at one point to allow him to sign a document. He is due back in court in June and is presumed innocent unless and until convicted.

#### Fordham Manor: 26-Year-Old Male Stabbed on East Kingsbridge Road

A 26-year-old man was stabbed twice in the leg during a physical altercation in Fordham Manor, police said. Police said they received a complaint on Tuesday, March 12, at around 8 p.m. regarding an assault in front of 1 East Kingsbridge Road. They said a 26-year-old male was involved in a physical altercation with an unknown male who stabbed the victim in the leg twice with a knife.

Police said the suspect fled the location on foot westbound on East Kingsbridge Road, and the complainant ran to his home and called 911. They said the victim was transported to St. Barnabus Hospital and is listed in stable condition, and added that no suspect description is yet available, and the investigation is ongoing.

#### Fordham Manor: One Woman Hospitalized, One Woman Arrested after Stabbing

One woman was hospitalized after a stabbing in Fordham Manor on Thursday, March 7, according to the City's emergency services. An EMS spokesperson said emergency services personnel received a call a 1.44 p.m. on March 7 for a reported stabbing at 2652 Bainbridge Avenue, located between East 194th Street and East 196th Street.

The spokesperson said one person was transported to St. Barnabas Hospital and their condition and description were unknown at the time. Citizens reported via the Citizens App that a woman had been stabbed in her left arm, and that a suspect has been arrested.

Norwood News contacted the NYPD for more information on the incident and a spokesperson later said they received a report of an assault at the location. "A 42-year-old female reported to police that on Thursday, March 7, 2024, at approximately 13.41 hours, she was slashed in the arm by an unknown individual in the vicinity of Marion Avenue and East 194 Street," an NYPD spokesperson said. "The victim was transported by EMS to St. Barnabas Hospital in stable condition."

Pursuant to an ongoing investigation, they said Amelia Benjamin, 46, of 2659 Bainbridge Avenue was arrested and charged with assault on March 12. She is presumed innocent unless and until convicted in a court of law.

#### Bedford Park: Man Attempts Robbery to Rob Store, Shoots Employee

The NYPD is asking for the public's help identifying the person seen in the accompanying

photo who they say is wanted in connection to an attempted robbery and assault that occurred inside a Bedford Park store. Police said that on Saturday, March 9, at around 2 p.m., a customer entered the store, located at 101 East 198th Street (a deli & grocery) at Creston Avenue, and while an employee was handing the customer some store merchandise, the customer attempted to grab it while simultaneously displaying a gun and threatening the 44-year-old male employee.

They said the victim attempted to struggle with the suspect, resulting in the suspect firing one shot in the victim's direction, before the suspect fled the scene. They said the victim was not injured and no merchandise was taken. Police said the suspect has a dark complexion and was wearing a dark-colored, hooded sweatshirt.

#### Fordham Manor: Food Vendor Beaten and Robbed at Gunpoint

Police are looking for five in-

dividuals who beat and robbed a food vendor on East Fordham Road on the border of Belmont and Fordham Manor on Feb. 26. Police said they were called to East Fordham Road and Third Avenue on Feb. 26 at around 11.05 p.m. when the 34-year-old victim reported he was working at the food cart, when five individuals approached him and demanded money.

Police said one member of the group displayed a black gun and hit the victim across the face causing swelling and injury. They said the others began to punch and kick him about the body. Police said the suspects stole an undetermined amount of cash as well as the victim's iPhone, before fleeing on foot, southbound, along Third Avenue. They said no arrests have yet been made in the case and no description of the suspects was available. They are continuing to investigate.





#### The New York Local Journalism Sustainability Act

The New York Local Journalism Sustainability Act would provide tax credits to local community-based newspapers for hiring local news reporters. It is important to lobby Gov. Kathy Hochul, Senate Majority Leader Andrea Stewart-Cousins, Assembly Speaker Carl Heastie, along with your local state senator and state assembly member to support this critical legislation. Most communities are down to one local daily or weekly newspaper.

Newspapers have to deal with increasing costs for newsprint, delivery and distribution as well as reduced advertising revenues and competition from the internet and other news information sources. Daily newspapers concentrate on international, Washington, Albany, business, and sports stories. They have few reporters covering local neighborhood news.

Weekly newspapers fill the void for coverage of local community news. I'm grateful that you have afforded me the opportunity to express my views via letters to the editor, along with others who may have different opinions on the issues of the day. Albany needs to join us in supporting weekly community newspapers. Readers patronize advertisers; they provide the revenues to help keep them in business. Let us hope there continues to be room for everyone, including the *Norwood News*.

#### **Student Loan Forgiveness**

I actually agree with the vast majority of Larry Penner's letter to the editor [*Norwood News*, March 7-20, 2024] on "Student Loan Forgiveness." I have several points I would like to add to it. First, as opposed to concentrating on the symptom of the problem - student loan forgiveness - concentrate on the problem itself: why is college so expensive? What kinds of outrageous perks and privileges are given to administrators and professors? When I went to college in the early 1980s, tuition was \$130 a credit. The son of one of the professors attended the school and was given free tuition. How many more colleges have situations such as these?

Second, Mr. Penner should not characterize individuals who don't pay their student loans as "deadbeats," but rather every case should be dealt with on a case-by-case basis. As far as Mr. Penner's suggestion that Congress enact legislation to guarantee refunds from those who owe money in the form of loans, it's been in place for decades. The federal government already snatches tax returns from those who owe student loan debt when a spouse files an "Injured Spouse" form. The state also snatches the return. The spouse files a "non-obligated spouse"

form.

#### Fines Paid by Former Bronx Elected Officials

Editor's Note: In response to previous letters from Richard Marias on whether certain former Bronx elected officials convicted of corruption have paid their fines, served their time, and received their pensions, we followed up on the matter with various sources, including, as directed by other sources, federal prosecutors for the Southern District of New York. The latter referred us to the Federal Bureau of Prisons. As of press date, we're following up with this bureau and will share the outcome of our findings.

New York City Mayor Eric Adams joined local Bronx elected officials on Thursday evening, March 14, for a visit to the Kingsbridge underpass, a wellknown gathering point for undomiciled individuals and for drug use.

Located underneath the Grand Concourse and East Kingsbridge Road in Fordham Manor, the mayor was accompanied by District 15 City Councilmember Oswald Feliz and Assemblyman George Alvarez (A.D. 78). Feliz later said of the tour, "Really appreciate @ NYCMayor & Assemblyman @GALVA-REZNYC for touring the Kingsbridge Underpass tonight. Quality of life issues here are escalating, affecting the entire community, & utterly unacceptable. Look forward to working together to ensure our community can live [with] dignity." *Norwood News* recently reported on the arrest of 16 people at nearby Valentine Avenue in the vicinity of East 192<sup>nd</sup> Street, located the other side of the Grand Concourse, who were charged with, among other offenses, drug trafficking. Meanwhile, on Friday, March 8, a 15-year-old male was shot at the entrance to the Kingsbridge Road subway station on the Grand Concourse and East Kingsbridge Road.

With the permission of her mom, *Norwood News* spoke to a 10-year-old student from the area after the shooting. She said she felt sorry for the innocent people in her neighborhood who "have to pay for what other people do." Asked if she got training at school on mass shootings, she said, "Not really. We just got fire drills and lockdown practice and sheltering...like to stay inside the building when there's stuff happening

around. Today, we had a lockdown practice."

Asked how it made her feel when she has to do the training, she said, "It makes me feel, like, scared. Even if it's a joke, sometimes I get scared. I just don't want it [anything bad] to happen [for real]. Asked if she felt others took the drills seriously, she said, "Some people do joke about it." She added that people should be careful going out and to pay attention to their surroundings. "Keep your awareness just like on," she said.

The mayor later referenced his visit to the area during a press conference in the context of quality-of-life, mental health, and sanitation concerns across the City, adding that a clean-up

of the area followed his visit. Local residents and educators have long complained about the prevalence of open [outdoor] drug use in the area. Many agree services *are* needed to assist those with addiction issues but have called for such services to be provided at a venue located away from young children who are habitually witnessing, at very close proximity, the effects of such open, outdoor drug use in plain sight.

They argue, for example, that the distribution of clean syringes by outreach workers should be handled at a venue or center situated away from schools. The matter was raised once again at a public safety forum held at P.S. 246 in Fordham Manor on Nov. 30 last year. P.S. 246 is located opposite Poe Park, a well-known site for open drug use.

Feliz had participated in a virtual

> community input discussion on the renovation of Poe Park playground on Feb. 28, together with local residents including members of Friends of Mosholu Parkland, NYC Parks, and Partnership for Parks.

> Some of the items discussed included flood hazard zones, managing storm water, heat mitigation, tree preservation, an accessible and inclusive redesign of the park, welcoming entrances, other design ideas like seating areas, green spaces, spaces for gathering/events, and water and other play features.

> Of the mayor's latest visit to the area, Feliz added, "@NYCMayor also joined us at Poe Park, and also the building I grew up in. We did lots of baseball/ wiffle ball here. He promised to join us for baseball, after we're done resolving these challenges!"

#### NY Senate Passes NY HEAT Act

The New York Senate voted to pass the NY HEAT Act, and now the Better Buildings New York Coalition is urging Albany leaders to protect ratepayers from escalating future costs and to include the full NY HEAT Act in their final budget agreement. They say 25% of all households that are energy-burdened could see their bills cut nearly in half, saving an average of \$136 each month, with the new law.

# **DOT Acts On Moped Chaos**

"Our streets must be safe for everyone — pedestrians, cyclists, and drivers alike," said New York City Mayor Eric Adams in the context of the road safety campaign launch on March 19. "E-bikes are a great way for New Yorkers to get around, but we must ensure that people riding them can do so safely. That's why we're launching this campaign as a part of our broader efforts to make our streets safer and adapt to the new ways our streets are being used."

In the context of the Norwood attempted assault on police, the NYPD is asking for the public's help identifying a male motorbike rider, aged 18 to 25, with a dark complexion who was wearing all black clothing when on March 14, at around 6.17 p.m., he damaged a moving, marked police vehicle with two uniformed, on-duty, police officer occupants.

They said, in part, the officers were traveling past 3555 Bainbridge Avenue when "an unknown, unidentified male motorist, recklessly operating a blue, two-wheeled vehicle did approach [..] and threw a brick towards the rear of the vehicle." They said the rider fled southbound on Bainbridge Avenue towards East Gun Hill Road and no injuries were reported.

On March 12, *Norwood News* witnessed a group of motorcycle / ATV riders at around 5 p.m. traveling through red lights up and down the Grand Concourse in Bedford Park. When we asked a resident if she had also seen the group on Tuesday, she said, "I've seen a lot of those, yeah. They're very reckless. I mean they're very scary. All those motorcycles in general are terrifying,"

*We* also witnessed a roving band on the Grand Concourse in Tremont earlier that evening of March 14. It's unknown if it was the same group as was later in Bedford Park.

The NYPD and EMS later said they responded to a separate motor vehicle accident the same evening at around 6.50 p.m. Police said, in part, "A 2019 Suzuki motorcycle, operated by a 23year-old male, was traveling westbound on Pelham Parkway approaching the intersection of Eastchester Road when an FDNY ambulance, operated by a 25year-old, male, on-duty EMT, was traveling northbound on Eastchester Road. As the ambulance entered the intersection it was struck on the passenger side by the motorcycle."

They said the Suzuki driver was later pronounced deceased at Jacobi hospital, both ambulance occupants were transported to a local area hospital in stable condition, and the investigation remains ongoing.

Meanwhile, DOT officials said they launched the new multi-platform, e-bike public education campaign, "Get Smart Before You Start" to promote the safe use of e-bikes. DOT Commissioner Ydanis Rodriguez said the new campaign aims to reduce injuries and fatalities. DOT officials said with nearly six percent of NYC adults reporting that they ride an e-bike or e-scooter once a week or more, the new campaign will use "compelling images" and "instructive audio" to inform users how to properly accelerate, brake, and operate an ebike at an appropriate speed.

They said DOT will also help newer riders know what to expect when riding an e-bike. They said last year, DOT installed a record 31.9 miles of protected bike lanes and installed the first "double-wide" bike lanes to better accommodate the increasing number of cyclists in New York City.

They said bike ridership reached an all-time high in 2023 and added that the agency is committed to both improving infrastructure to better accommodate e-bike users and expanding enforcement against the most dangerous behaviors on the road. They said the million-dollar safety campaign is part of DOT's \$280 million Vision Zero expense budget for the next fiscal year and the agency's \$7.7 billion, 10-year capital plan for Vision Zero-related projects.

Rodriguez said, in part, "Our datadriven process shows that this new campaign is a timely and necessary response to the rise in fatalities that involve e-bike riders. E-bikes are an efficient and environmentally friendly way to get around and we hope that this campaign will encourage their safe operation."

We asked DOT if the campaign relates only to e-bikes or both e-bikes and gas-powered motorcycles/dirt bikes/ ATVs. We did not receive an immediate

response as of press date. A breakdown of different types of vehicles accompanies this story. When asked, the NYPD press office was unable to confirm if all of the bikes involved in the referenced incidents were e-powered or gas-powered. According to online research, ATVs can be e-powered as well as gas-powered.

On March 20. DOT officials said the relaunch of the red-light camera program coincided with the release of its Red-Light Camera Report showing what they said was "the tremendous safety benefits of red-light cameras." They said the report shows red light cameras located at fewer than 1% of the city's intersections dramatically reduce red-light running and dangerous crashes.

They said the latest push comes amid a record surge in traffic fatalities attributable to red-light running. Last year, they said 29 people died from redlight running, an all-time high, adding that all occurred at intersections without a red-light camera.

Attendees at the event called for the passage of bills to renew and expand the red-light camera program and to crack down on the city's most reckless red-light runners. They said the bills would expand the camera program from fewer than 1% of the city's intersections to 10% of intersections with a traffic signal. A companion bill would require the State Department of Motor Vehicles to revoke the vehicle registration of vehicles in receipt of five or more red-light camera violations over one year. A further DOT safe cycling campaign launch is set for March 22.

Prior to the launch of these campaigns, on Sunday, March 17, at 2.40 p.m., around 20 vehicles were seen in Norwood by Norwood News traveling northbound towards Woodlawn along Jerome Avenue at Mosholu Parkway North. They were followed by at least three unmarked police vehicles with a siren, and several NYPD patrol cars and vans. At 3:02 p.m. three ATV riders were later seen returning southbound on Jerome Avenue, where one was observed briefly mounting the sidewalk. This time, the bikers were pursued by several police vehicles and an NYPD helicopter overhead.

According to police radio transmission, the pursuit began on the Grand

Concourse and continued north into Norwood and Woodlawn. When we queried the chase with the NYPD, a press official said, "There is no report on file based on the information provided."

Speaking at the 52nd Precinct Community Council meeting on Feb. 22, 52nd Precinct Captain José Gomera said, "I know the last time we had a lot of complaints about the scooters." Gomera added that in the prevailing 28day period, officers from the 52nd Precinct had seized 171 scooters, bikes, and mopeds, had issued 31 summonses, and had made 29 arrests.

He added that year-to-date, 354 illegal vehicles had been seized, 48 summonses issued, and 45 arrests had been made. "Confiscating scooters is a dangerous job to do because sometimes these guys flee from us and they could fall, and then it's going to be on the officers, right, if something happens to the motorist as well, and we also want to prevent anyone from getting hurt," he said.

As reported, Eric Duprey, 30, died after he was hit by an ice cooler and knocked off his moped by NYPD Sgt. Erik Duran of the NYPD Narcotics Borough Bronx (NBBX) during a fourth "buy-and-bust" operation or undercover drug purchase of the day, on Aug. 23, 2023, at 2505 Aqueduct Avenue in Fordham Manor. Attorney General Letitia James announced on Jan. 23, that manslaughter charges had been brought against Duran, 37, of Putnam County. Duran is presumed innocent unless and until convicted in a court of law.
