HUNDREDS VOICE HOPES AT ARMORY HEARING

Around 300 people, including dozens of union members, residents, and members of Northwest Bronx Community & Clergy Coalition (NWBCCC) showed up to voice their hopes, needs, intentions, and aspirations for a successful Kingsbridge Armory redevelopment during the second public hearing (and first inperson) held June 3 at Kipp El-

ementary School in Kingsbridge Heights on the City-owned, longvacant Armory.

The hearing, hosted by Bronx Community Board 7 and an NYC Department of City Planning (DCP) requirement under the Uniform Land Use Review Procedure (ULURP), followed an earlier announcement the same day that 8th Regiment Partners, the winning redevelopment bidder,

had entered into a joint partnership with NWBCCC, a losing bidder, formalizing 20% community ownership and governance of the soon-to-be-developed site.

Several elected officials joined Councilmember Pierina Sanchez (C.D. 14), co-chair of the Armory redevelopment working group, together with Sandra Lobo, NWBCCC executive director, 8th Regiment Partners, NYC Economic Development Corporation (EDC), and other NWBCCC members and unions for the announcement.

The Armory's protected status as a historic building and the largest armory in the country limits what it can be used for, but after a 9-month, public engagement process and "rigorous" Request for Proposal (RFP), in Jan-

Rivera Endorses Sanchez in D14 where Average Worker earns \$25K/Year

State Sen. Gustavo Rivera (S.D. 33) formally endorsed Council Member Pierina Sanchez (C.D. 14) for reelection to her Bronx council seat in the upcoming Democratic primary during a campaign event held in conjunction with the Unity Democratic Club last month at Fort #4 Playground, located at 2890 Sedgwick Avenue in Kingsbridge.

The councilwoman, a progressive Democratic like Rivera, first won her seat in November 2021 and C.D. 14 broadly covers some or all of the neighborhoods of Morris Heights, University Heights, Fordham and Kingsbridge.

Her predecessor, former City Councilman Fernand Cabrera, is running in C.D. 14 again, this time to unseat Sanchez, who is also running on the Working Families Party ticket. At the rally, Rivera said, "I knew that this is a lady who needed to be in elected office because we have a lot of us that work in public service and not everybody's built for elected office."

He added, "But I had a sense that she was, and it was exactly the right time for her, and more importantly, was the right time for this community." Explaining that he had lived in C.D. 14 for 23 years before he had to move when the senatorial district lines were redrawn in 2023, he said when Cabrera was termed out, Sanchez had an opportunity. "This is a neighborhood that I know well," Rivera said. "We want to make sure the community in this neighborhood continues to be represented with the quality that this lady brings to the table."

He added, "She's somebody who's not only a smart woman, she's a hardworking woman, she's a committed woman, and you'll know by some of the enemies that she has made, you will know by some of the enemies that she has made [he repeated], what kind of person she actually is in public office, which is exactly [why] we need to keep [her] in public office."

The councilwoman, who has given birth to two children since taking office a few years ago, thanked Rivera for his support before moving on to the issues facing her district today. "We're in a moment where the City is under attack, where our City, our programs, the so-

cial safety net, not just in New York City but across the country, is under threat, right?" she said, in a presumed reference to the latest policies of the Trump administration.

"We have threats against education, we have threats against Medicare, and Medicaid, we have threats against social security, we have threats against all of the programs that support our families across the nation." She added that as residents try to move into the next socioeconomic group, it was important to have Rivera's support.

"Because y'all, he's been fighting this fight before there was a label," Sanchez said. "He's been fighting this fight and serving our community, fighting for that social safety net and beyond, since before there was a label that was cool or not cool, a progressive." The councilwoman went on to say that Rivera knew her constituents to be "a community of strivers."

She continued, "We're a community where the average worker is earning just \$25,000 a year, where we want to make it, we want to work hard, but there's a lot of obstacles against us and so, it's so important to be able to say we're going to invest in education, we're going to invest in the Kingsbridge Armory, we're going to get it right this time around, and we're

going to do all of this work together, no matter who is against us." (Read more on the armory in our front-page story.)

As reported, Agallas Equities, a losing bidder of the Kingsbridge Armory redevelopment RFP, filed a lawsuit against NYC Economic Development Corporation (EDC), 8th Regiment Partners, the winning redevelopment bidder, and various current and former elected and city officials in late March.

Agallas broadly alleges corruption and stolen intellectual property amid the RFP process and has also asked NYC Department of Investigations to investigate a potential conflict of interest. Sanchez is not named in the suit and the City denies any wrongdoing and is moving ahead with the selected developer.

Sanchez joined Bronx Rises Against Gun Violence (B.R.A.G.) for a rally on May 9 outside her office following a non-fatal shooting which took place in the building next door at 2065 Morris Avenue in Fordham Heights on May 5. In efforts to address gun violence and crime in District 14, she founded the West Bronx Community Safety Partnership, securing a commitment from Gov. Kathy Hochul of \$10 million in resources to uplift neighborhoods with a public health and community-driven approach to safety.

Five Teens Missing from Castle Hill Group Home

Police are investigating the disappearance of five female teenagers from a Castle Hill foster home, all of whom went missing on different days in less than a month. For the security of those living at the home, we are not disclosing its name or location.

According to the NYPD, Jy-Lee Connor, 14, left the home at 7 p.m. on Wednesday, May 14, and has not been seen since. Police announced that Jayleen Suarez, 15, left the home at 7.30 a.m. on Friday, May 23. Suarez has not yet returned.

On Tuesday, May 27, police say Jailynn Gray, 16, left the same home at 7.55 a.m. on Tuesday, May 27, and has not returned. On Tuesday, June 10, police announced that Dezi Whittingham, 15, disappeared after leaving the same home at 12.45 p.m. on Saturday, May 31.

While gathering information to complete this story, the NYPD announced on Wednesday, June 11, that a fifth teen, Yelena Baergea, 17, left the home at noon on Sunday, June 7, and has not been seen since

After Grey's disappearance, *Norwood News* asked the NYPD press office if the then-four missing persons cases were being handled by the 43rd Precinct's Missing Persons Squad or by the Special Victims Unit. Our request went unanswered.

An hour after Baergea left the home, we asked a female employee who was exiting the building about the missing teens. The unidentified woman replied, "I cannot...um...let me tell you... Let me call..." The woman then made a call on her cell phone apparently to her manager, saying, "Mrs. Hobert, I have a reporter in front of the home. Yes. No prob, okay. So, okay. All right. He said there's a missing teen from the home."

After hanging up, the employee said, "No, she said there's no public relations." Asked if she could say who operated the home, the employee replied, "I can't do that." She then walked away.

We also reached out to the Administration for Children's Services (ACS) who were looking into the matter of the missing youths. Following some research, we asked ACS if Catholic Guardian Services ran the home. We were later informed that it is one of the provider agencies contracted by ACS.

On Wednesday, June 11, Norwood News spoke with a Mrs. David at Catholic Guardian Services by phone to inquire about the missing teens. "I can't talk to you," she said before she put the phone down for several minutes. During this time, it became clear she was in the middle of a work-related meeting that focused on the children being cared for at the home and the services they provide or do not provide, such as beds. Later, on picking up the phone, David promised someone would respond to our inquiry.

Norwood News also reached out to the Archdiocese of New York, as well as Catholic Charities to ask about any potential affiliation to Catholic Guardian Services as they all share the same First Avenue address. We had not received a response as of press date.

On June 11, we spoke with a young woman who was a former resident of the facility, who said it caters to teenagers and young women who are in the foster care system and pregnant. The former client said, "They treated me like sh*t." She added, "These staff members (are) basically there for a paycheck."

The former client of the home also alleged that staff members don't care about

the health or wellbeing of clients, and that staff members round up babies and place them in the center of the living room and "watch TV."

The former client continued, "I know a lot of the girls when they are there, the support, it's like they don't get any guidance from actual adults that care about them, so they end up doing their own thing. And since they kind of live near the projects, a lot of predators kind of like try to talk to the girls."

The former client added that she applied for a job at the home, explaining, "Because I wanted to be different than the staff that was there." She said she was never called in for an interview.

According to its website, Catholic Guardian Services, a non-profit, had an operating budget of \$84,305,683 for fiscal year 2022-2023, with \$82,484,284 paid by taxpayers. A March 2023 disclaimer from Wikipedia on the Wikipedia page for Catholic Guardian Services, reads, "This article contains wording that promotes the subject in a subjective manner without imparting real information. Please remove or replace such wording and instead of making proclamations about a subject's importance, use facts and attribution to demonstrate that importance."

According to Wikipedia, Catholic Guardian Services oversees 34 residential facilities and employs 1,200 employees. It is a human services nonprofit, and its programs assist members of the disadvantaged population of the New York metropolitan area. It is sponsored by Catholic Charities of the Archdiocese of New York and operates fifteen distinct programs, providing a range of services.

These include services in the areas of child abuse and neglect prevention, fos-

ter care, maternity services, and developmental disabilities. Its mission is also supported remotely by over 600 foster and adoptive parents. CGS's programs and services are delivered in partnership with the Archdiocese of New York, the New York City government, the New York State government, education agencies, foundations, policymakers, and advocacy groups.

An ACS spokesperson later shared the following statement with us in response to our inquiries. "We always prioritize the safety and well-being of our youth in foster care. In the event that a young person in foster care leaves their foster care placement and cannot be found, our investigative consultants work closely with law enforcement and the young person's foster care agency to locate the young person and ensure their safety. Over the past several years, we have also expanded resources for youth in foster care to connect them to positive role models, and to promote their safety and success."

We were informed by ACS that NYS law prohibits the agency from disclosing whether or not a child is in foster care as the case information is confidential. We were also informed that ACS has around 120 investigative consultants, who are retired NYPD detectives, on staff who work closely with law enforcement to support the agency's most vulnerable youth and teenagers and help locate them if they go missing.

ACS representatives said anyone who suspects child abuse or neglect is urged to call 911 or 1 (800) 342-3720.

May marked National Foster Care Month, a time to raise awareness about the challenges faced by children and youth in foster care and to recognize the dedicated individuals who support them.



This week, we asked readers for their opinions on the proposed cuts by the Trump administration to Medicaid and Medicare and how it would affect them. According to ABC News, a large part of funding for the Trump administration's second term agenda comes from cuts to safety net programs like Medicaid, the health care program for lower-income Americans. U.S. President Donald Trump's so-called "big, beautiful bill" that recently passed in the House makes around \$600 billion in cuts to Medicaid, the outlet reported, adding that about 10.9 million people could lose their coverage over the next 10 years, according to a recent estimate by the Congressional Budget Office. Meanwhile, on June 5, NBC reported that in looking at new ways to pay for the president's domestic agenda, Republicans are exploring ideas to slash "waste, fraud and abuse" in Medicare, according to several senators. Medicare is a federal health insurance program for people aged 65 or older.



"The only thing I can tell you is that from what I'm hearing [U.S. President Donald] Trump is not touching that, but I don't know. I don't know too much about it, but the only thing I like about this bill is that in the bill, it has no tax on tips and no tax on overtime; that I like. But closing hospitals, that I don't like."

Bedford Park Man Arrested after Boat Fire Results in One Critical & 22 Rescued

The FDNY said their emergency unit rescued 22 people from a boat that caught fire on Saturday, June 7, in the vicinity of 262 Fordham Street / Hart Island Ferry Terminal. Meanwhile, police said a Bedford Park man has been arrested with a DUI offense in connection with the incident.

An FDNY spokesperson said the department received a 911 call at 7.59 p.m. on Saturday for a report of a boat fire with multiple people in the water. They said upon arrival three patients were rescued from the water by FDNY's marine units and all fire on the boat was extinguished.

They said the both the department's marine units and land units responded and rescued 22 patients in total. They said two refused medical attention, and one was transported in critical condition to Jacobi Medical Center. They said 19 people incurred non-life-threatening injuries and were transported to area hospitals, and all other civilians swam to Hart Island. They said the cause of the fire is under investigation.

In images posted to social media of the incident, it does not appear that passengers were wearing life jackets. The FDNY later said that FDNY Marine Units responded to reports of a boat fire "near City Island" in the Bronx, adding that there were 22 people on the boat.

"Marine 4 gave a verbal for a boat fire and multiple people in the water to The Bronx dispatcher," FDNY Assistant Chief Michael Meyers said. "At that point, the Bronx dispatcher had land units respond to come into City Island and begin to accept patients. Marine 4 grabbed three people out of the water."

Meyers added, "At that point, they transported them to one of the docks that was close by, where Engine 70 was waiting, and EMS was waiting as well to begin CPR on the victims." He continued, "The other 19 folks swam to Hart Island. They were just off the east end of Hart Island, and then they were picked up by the NYPD Coast Guard and FDNY boats and transported back over to the docks at the Yacht Club on City Island."

The fire chief concluded, "This just goes to show you what a coordinated effort happens between our marine units, our land units, and our EMS units to get here to help save lives, by responding in here, by communicating well, and by working with our City partners to help ensure that we protect the people of the City of New York."

Meanwhile, the NYPD said they received a call at around 7.59 p.m. for a report of boat fire in Long Island Sound in the vicinity of Hart Island. They said the NYPD's harbor unit, aviation unit, and drone team responded, along with the FDNY and EMS.

"In total, 23 people were transported to local area hospitals," an NYPD spokesperson said. "Twenty-two patients sustained minor injuries and

were transported in stable condition. One patient sustained serious injuries and was transported in stable condition. The investigation remains ongoing by the NYPD and United States Coast Guard."

They said Joshua Brio, 33, of Bedford Park, The Bronx was arrested on June 7, at 9.04 p.m. He was charged with reckless

endangerment with first degree, driving while intoxicated (with alcohol or drugs), and a further charge of driving while intoxicated ("first offense").

When contacted, we were informed by an NYC Parks spokesperson that the department does not allow recreational boat access to Hart Island, but the Parks' department does operate special pre-arranged tours while it undergoes restoration and preservation. When asked, we were also informed that NYC Parks does not regulate use of the waterways around the island.

On Sunday, June 8, we spoke to some residents and some visitors of residents who live in the same building as the Bedford Park man who was arrested but none knew him or were aware of the incident.

According to the NYPD, Brito lives

in an 11-story, assisted living building located in Bedford Park run by the City since it opened in September 2024. One resident said it's owned by CHV Bedford Park, LP; and run by Gen or Genuine Corporation of Emerson, New Jersey.

Residents of the building said it has "low income" tenants, shelter residents, and residents who came from a shelter catering specifically to domestic violence victims. For this reason, we are not disclosing the location.

When one female resident was told the captain of the boat lived in her building, she replied, "In this building? What! He died?" When informed he was under arrest, she asked, "For what?" When told he was charged with a DWI, she gasped.

A second woman said, "That's why the cops were here the other day." She

OCM Recalls Cannabis Products by IndoGrow LLC

New York State's Office of Cannabis Management (OCM) issued a recall on multiple adult use cannabis products produced by IndoGrow LLC on June 11. OCM officials said the regulated cannabis products are being sold through licensed cannabis adult use dispensaries throughout New York State.

They said the affected products were originally quarantined due to a lack of validity in testing by a former permitted laboratory, adding that OCM authorized a re-test of the products, and nine (9) lots failed due to the presence of unallowable

pesticides, posing a potential risk to public health and safety. The following products in the chart below, which may also be known by names that may include "Indi," "Grow by Indi," "Our Creation" and "Grow with Us," have been recalled as a precaution, though OCM officials said they had not received any reports of illness:

NYS Senate Passes Ground Lease Co-op Bill

The NYS Senate passed the Ground Lease Co-op Bill on June 10, marking what advocates of the bill said was a key step forward in securing protections for more than 25,000 ground lease co-op residents vulnerable to displacement due to longstanding gaps in New York State housing law. The Senate advanced the bill 34-28, and advocates, including the Ground Lease Co-op

Coalition, say they are confident the NYS Assembly will carry it across the finish line before the end of the legislative session in June.

Advocates say long-term ground leases are beginning to expire statewide for more than 10,000 apartments, and unlike traditional coops, ground lease co-ops own their homes but lease the land beneath their buildings from landowners. Originally established to support middle-class homeownership, advocates say more than half of New York's ground lease co-ops are located in The Bronx, Brooklyn, and Oueons

They say as land values reach all-time highs and outpace typical incomes for residents, the bill introduces critical protections to help New Yorkers in ground lease co-ops fend off predatory rent increases and preserve the ability to stay in their homes in the event of deconversion. In particular, they say the bill ensures residents will benefit from the same protections under rent stabilization laws as all other rent stabilized buildings, and secure reasonable first rents if their co-op is forced to de-convert.

They say this provides a path for them to stay in their homes and the bill also seeks to guarantee the ability of tenants to borrow for required repairs and capital improvements, the right of first refusal, and tenant protections upon deconversion, including rental leases for existing residents. They say ground lease co-ops continue to house New York's middle class, with the majority of residents earning just above the city's median of \$76,000 across all five boroughs.

NYS Medical Aid in Dying Act Passes Both Houses

New York's Medical Aid in Dying Act (https://bit.ly/4jMD6rN) has passed both the NYS Assembly and NYS Senate and now awaits signature by Gov. Kathy Hochul. If signed, New York will become the 11th state, along with Washington, D.C., to enact such legislation, according to reporting by New York News Connection. The law, if signed, allows a person who has been determined by two doctors to be mentally capable of making an informed decision and who has only six months to live to receive medical aid in dying.

Queens Assemblywoman Jessica Rojas (A.D. 34) announced on Tuesday, June 10, that the New York State Assembly passed her bill (A128A) to ensure New Yorkers who need asthma inhalers can access them for free, with no copays, no cost-sharing, and no deductibles. The bill has already passed in the Senate and now awaits signature by Gov. Kathy Hochul. Rates of asthma in The Bronx are among the City's highest.

Over 215 Groups Demand Reversal of HALT Law Suspension

Over 215 organizations have sent a letter dated May 27 to Gov. Kathy Hochul and State Prison Commissioner Daniel F. Martuscello III, demanding State prisons immediately rescind what the organizations say is the "illegal" suspension of the HALT Solitary Confinement Law and instead fully implement the law.


Anisah Sabur, a Bronx resident, national coordinator of the "Unlock the Box" campaign, and a survivor of solitary confinement in New York, said HALT was previously enacted some years ago by a supermajority of both houses of the State legislature and signed into law by the governor.

Sabur said the letter also urges enactment of legislation that creates meaningful pathways of release from, and fundamentally change the environment within, New York's prisons, including laws relating to elder parole, fair & timely parole, "second look," earned time, the Marvin Mayfield Act, Rights Behind Bars, and ending qualified immunity.

Letter signatories include the Bronx Defenders, NYS NAACP, NYS Defenders Association, The Legal Aid Society, the American Civil Liberties Union, the Vera Institute of Justice, and more. Sabur said that 55 State legislators also recently urged NYS Department of Corrections & Community Supervision (DOCCS) to end what they say is the "illegal" suspension and fully implement HALT. Sabur said The Legal Aid Society also filed a lawsuit, challenging the suspension.

Jerome Wright, co-director of the #HALTsolitary campaign, said he knows from personal experience that solitary confinement is "torture." He said, "The social isolation wreaks havoc on people's minds and bodies, has led to numerous people dying, and makes everyone less safe. I also know from running and creating programs [with] real alternatives, involving full days of outof-cell programming and human engage-

Two Bronx Members of the NYPD Arrested for Attempted Assault/Assault

The NYPD said an off-duty NYPD officer was arrested on Tuesday, June 10, at 3.16 a.m. within the confines of the 49th Precinct which covers the neighborhoods of Allerton, Morris Park, Van Nest, Pelham Parkway, Eastchester Gardens, and Pelham Gardens.

They said Officer Edgard Delossantos, 27, who became a police officer in July 2021, was charged with attempted assault. Delossantos is assigned to the 44th Precinct, which broadly covers parts of the Grand Concourse, Bronx Terminal Market, and Yankee Stadium.

Police also said that on Tuesday, June 10, at 3.16 a.m., off-duty NYPD Detective Melissa Negron, 42, was also arrested in the confines of the 49th Precinct. They said she was charged with assault. Negron is also currently assigned to the 44th Precinct. She became a police officer in 2006 and was promoted to detective in September 2014. Both defendants are presumed

innocent unless and until convicted in a court of law.



Norwood: MTA Female Employee Assaulted on BX-10 Bus

The NYPD is asking for the public's help identifying a person above who they say is wanted in connection to an assault that occurred in Norwood. They released the accompanying image of a person of interest. Police said that on Monday, May 19, at around 8.40 a.m., an unidentified person

sprayed an unknown substance into the face of an on-duty, 33-year-old female MTA employee onboard a BX-10 MTA bus in the vicinity of Bainbridge Avenue and Van Cortlandt Avenue East. "The individual then fled the location to parts unknown," the spokesperson said. "The victim was transported to Montefiore Medical Center in stable condition."

Norwood: Man Sought for Reckless Shots Fired on E 209th Street

The NYPD is asking for the public's help identifying and locating the person seenat right in the accompanying photo who they say is wanted in connection to shots fired in Norwood. Police said that on Saturday, May 24, at around 8.05 p.m., an unidentified man fired multiple shots in front of 365 East 209th Street. "The individual then fled westbound on East 209 street on foot to parts unknown," a police spokesperson said. "There were no injuries reported as a result of this incident." Police said the suspect is described as male and was last seen wearing a white

surgical mask, a black, hooded sweatshirt, black sweatpants, and black sneakers.

ment, dramatically reduce violence and better protect people's health."

He added, "The HALT Solitary Law follows that well-documented evidence, but since HALT went into effect in 2022, DOCCS has systematically violated the law by failing to implement real alternatives and continuing to lock people in solitary by another name for months and years. Guards tried to stop the HALT Solitary Law through the democratic legislative process, the courts, and by outright ignoring the law. But the public, a supermajority of elected leaders, and the courts have all said New York State will not continue this torturous and dangerous practice. Incarcerated people's lives matter too."

Meanwhile, Harvey Rosenthal, chief executive officer of the Alliance for Rights and Recovery, a coalition of New Yorkers with major mental illnesses and trauma histories, said there was perhaps no greater pain than that of experiencing the mental health trauma of solitary confinement. "A supermajority of New York lawmakers recognized how torturous solitary is and how it *worsens* safety for everyone," he said.

"DOCCS must immediately rescind

their unlawful order suspending the HALT Solitary Law and must fully implement the HALT Law, including true alternatives proven to reduce violence and better protect people's health. New York's prisons must not continue to deny our most vulnerable New Yorkers more humane alternatives to this soul-crushing and life-taking trauma and torture."

Norwood News reached out to both the governor's office and DOCCS for comment. The governor's office referred us to DOCCS and a DOCCS spokesperson said, "Due to the 22-day illegal strike and ongoing state of emergency system wide, the programming elements of the HALT Act were paused for the safety of both the incarcerated and our staff. The Commissioner has conducted periodic reviews of each facility to assess feasibility and safety of resuming programming, and several facilities have been able to resume HALT programming."

The spokesperson added, "We expect more to follow in the near future. We continue to conduct safety and operational reviews on a facility-by-facility basis in order to ensure that when programming recommences, it's done so in manner that prioritizes the safety and security of those in our care, our

staff, and the community. Correction Law §2(23) specifically allows DOCCS to suspend the programming elements of the segregated confinement rules when there is an emergency or exigent circumstances. Additionally, and separate from the provisions of Correction Law §2(23), Correction Law Sec. 137, allows the Commissioner to exercise his authority to suspend the program provisions of the HALT Act."

added that police were inside the building until after midnight on Saturday. Asked if she knew Brito, the resident said, "No, but I do know they (the police) came in here." A male resident who had not seen the video added, "Wow! Really?"

Unable to reach Brito for comment, we tracked down another man with the same name who also lives in The Bronx. Once informed what the phone call was about, the man said, "You've got the wrong Joshua Brito, I'm not the boat guy."

Asked if he had heard about the boat fire, he replied, "Yeah, you're the third call I've gotten already." When asked if he saw the video of the fire, he responded, "I don't know if I saw the right one, but that's crazy, this whole incident." When informed what the video shows, he said, "No way! I'll have to look this up."

Asked what he thought when he heard a man with the same name as his was arrested, he laughed and said, "I was, like, hey! They got the wrong one. A lot of people were calling me like, 'Hey! Are you okay?' and 'What happened?' That's what I was saying. Like, I don't even own a boat."

According to the Bronx District At-

torney's Office, Brito was arraigned and released on Monday, June 9. He pleaded not guilty, and his next court date is in July. According to the criminal complaint, police observed Brito standing behind the steering wheel of a white Carver cruiser with the engine running while the boat was moving.

A police officer also noted that Brito had "watery eyes and a strong odor of an alcoholic beverage emanating from his breath." According to complaint, Brito told a separate member of the NYPD, "I was driving the boat. I had one beer," and subsequently, "I picked up the group at World Fair. I had an issue with the boat two days ago. I disconnected the generator."

According to the criminal complaint, a breathalyzer test carried out on June 7 at 10.09 p.m. at Jacobi Hospital on Brito and it yielded results of .05 blood alcohol concentration (BAC). Brito is presumed innocent unless and until convicted in a court of law.

Members of Fordham University's rowing club were rescued in The Bronx after their boat capsized in Eastchester Bay close to Rodman's Neck in May 2024.

Editor's Note: The following is a copy of a letter sent to NYS Gov. Kathy Hochul and NYS Commissioner Daniel F. Martuscello III dated May 27, 2025, and signed by over 215 groups. Dear Governor Hochul and Commissioner Martuscello,

We, the undersigned organizations, demand that you immediately reverse the illegal purported suspension of the HALT Solitary Confinement Law and instead fully and effectively implement it. Despite DOCCS doubling down on its attempts to suspend HALT, nothing in the HALT Solitary Law authorizes a suspension of any parts of the law. Carrying out this "suspension" directly violates the HALT Solitary Law, illegally usurps the lawmaking function of the state legislature, and causes grave harm and likely death.

Solitary confinement is torture. It inflicts immense suffering, devastating harm, and too often death. Studies show that people in solitary are

between six and 12 times more likely to engage in acts of self-harm or die by suicide. Solitary is disproportionately inflicted on Black and Latinx people. Solitary confinement also worsens safety for everyone by causing people to deteriorate physically, mentally, and emotionally. At the same time, true alternatives to solitary – involving full days of meaningful out-of-cell human engagement and programming – have been proven to reduce violence and better protect people's health and safety.

Recognizing that longstanding evidence, supermajorities of both houses of New York State's legislature passed the HALT Solitary Law and your predecessor Governor signed it into law. HALT Solitary is the law of New York State and DOCCS does not have the authority to push it aside.

It is particularly egregious that DOCCS has taken this unlawful step seemingly as a capitulation to the demands of officers who illegally carried out a statewide work stoppage that put tens of thousands of New Yorkers' lives at risk by resulting in massive lockdowns and limited or no access to family visits, food, medications, medical and mental health care, programming, out-of-cell time, parole board hearings and more. It has been reported that at least 12 people died while nearly the entire prison system was locked down in solitary because of the illegal work stoppage. It is also particularly egregious that DOCCS has taken this unlawful step after the world watched 17 DOCCS staff - officers, sergeants, and medical providers - brutally beat Robert Brooks to death and less than three months later officers reportedly brutally beat Messiah Nantwi to death.

Beyond ending the illegal purported suspension, DOCCS must fully and effectively implement the HALT Solitary Law. DOCCS has been systematically violating the HALT Solitary Law since it went into effect, continuing to lock people in solitary confinement by another name for months and years at a time. Among other violations, DOCCS has been illegally locking people with disabilities in solitary, illegally sending people to solitary and alternatives for reasons prohibited under the law, illegally denying people access to the seven hours of daily group out-of-cell time required in purported alternatives, illegally claiming that locking someone alone in a tiny recreation balcony in the back of their cell is "outof-cell" and "congregate out-of-cell" time, and illegally failing to utilize the mechanisms of release from alternatives while imposing extreme sentences to solitary, thereby warehousing people in units that are solitary by another name for months and years at a time.

Enough is enough. DOCCS is not above the law, and must implement all components of the HALT Solitary Law. In addition to reversing all of the violations above, DOCCS must expand the use of community-led and peer-led programs in alternatives to solitary, such as the proven M.A.N. Program. DOCCS must also bring in outside experts, such as Dr. Bandy Lee and Dr. James Gilligan, and provide them full autonomy to design and operate units in a manner akin to the original RSVP Program or the former Merle Cooper Program, which involved full days of

out-of-cell group programming and engagement and saw positive impacts on safety for everyone.

In addition to fully implementing the HALT Solitary Law, we urge you to release people who are incarcerated through expansive use of executive clemency and medical parole, starting with those who are elderly and most vulnerable; restore full family visits at all facilities; end all lockdowns; stop all officer brutality, sexual violence, and other abuse; reverse the family care package ban; and support legislation that will create meaningful pathways of release from New York's prisons and fundamentally transform the environment within New York's prisons, including Elder Parole Bill (S454/A514) and Fair & Timely Parole (S307/A162); the Second Look Act (S.158/A.1283), Earned Time Act (S.342/A.1085), and Marvin Mayfield Act (S.1209/A.1297); Rights Behind Bars (S3763/A1261A); and Ending Qualified Immunity (S176/

Hundreds Voice Hopes at Armory Hearing

uary, EDC selected 8th Regiment Partners' project submission.

Called "The Kingsbridge Center / El Centro Kingsbridge," the winning proposal is a two-phase, multi-use project expected to be finalized some time in 2030 and 2032, respectively.

Phase I will consist of a mixed-use development with a venue space and entertainment uses, sports fields, cultural and commercial space, light industrial manufacturing space, an educational facility focused on workforce development, and over 25,000 square feet of dedicated community space.

Phase II includes around 450 units of permanently affordable, multi-story, rental housing which will be constructed adjacent to the Armory, where currently the National Guard operates from two annexes on West 195th Street, between Jerome Avenue and Reservoir Avenue. The height of the residential building will exceed the roof height of the main armory building.

The redevelopment is backed by a \$200 million investment by NYC Mayor Eric Adams and NY Gov. Kathy Hochul, a further \$2 million from Bronx Borough President Vanessa Gibson, \$12 million from Sanchez, and a \$1.05 million grant from the U.S. Department of Housing and Urban Development (HUD), with the support of U.S. Rep. Adriano Espaillat (NY-13).

Lobo said the latest partnership marks a transformative shift in how development can and should happen in Bronx communities. "For decades, Bronx residents have organized for a say in the future of the Kingsbridge Armory," she said. "We're proud to have secured a model that reflects what the community has always called for: shared governance, community ownership and real investment in our people."

According to 8th Regiment Partners and NWBCCC, the partnership "aligns with long-term community interests" and "includes unprecedented elements in a City-owned project." These include two long-term, subleased, community-owned, developed condos, comprising over 20 percent of the total site footprint dedicated to community use.

One condo will serve as a 25,000-square-foot community hub providing space for community activities, work-force development, entrepreneurship and worker cooperative business development, and the other will offer up to 100,000 square feet for affordable light manufacturing aimed at accommodating Bronx-based businesses that have been displaced from the borough.

A Master Condo Association will guarantee that community-owned portions of the project will help govern major operational and strategic decisions. Up to 20,000 square feet of affordable commercial space is to be set aside for small and local busi-

nesses during the housing phase of the development, focusing on vulnerable businesses along the Kingsbridge corridor.

In addition to an already agreed Project Labor Agreement (PLA) with NYC building trades announced in January, a further commitment has been obtained to encourage neutrality agreements that ensure quality, family-sustaining jobs, and protection of workers' rights to organize across the site.

Lobo said a Memorandum of Understanding (MOU) was signed on May 28 between NWBCCC and 8th Regiment Partners, securing NWBCCC's role as codeveloper of approximately 20% of the entire Armory site. She said it also includes commitments to establish a Community Council, and a Community Benefit Fund, to support the arrangement.

In addition, she said the MOU secures a commitment from 8th Regiment Partners to sign a Community Benefits Agreement (CBA) with a broader coalition of labor, community, small business, and faith-based stakeholders which will be negotiated during the ongoing ULURP process.

A first (virtual) public hearing was held on May 31, and a 60-day community board review led by Bronx Community Board 7 is currently underway.

We asked Lobo if NWBCCC was putting up any financing towards The Kingsbridge Center project. She said, "At this stage, NWBCCC's contributions are focused on program development, and coordinating public subsidy and philanthropic support for the community-owned components. NWBCCC will be responsible for securing capital and operating resources to build out and activate the spaces we will co-develop within the Kingsbridge Armory."

Meanwhile, Gabriella Sottile, on behalf of 8th Regiment Partners, said the development team was crystal clear about understanding the value of strong community partnerships. "We look forward to having the Northwest Bronx Community and Clergy Coalition not only as a long-term tenant but a key partner in this project for years to come," sha said in part.

The MOU parties said the partnership also commits to maintaining high environmental standards, and the Community Council will provide ongoing input on tenant mix, programming, and additional strategies for community investment. Additionally, they said the Community Benefit Fund, funded through project revenue and governed by the Community Council, will support long-term local investments in initiatives aimed at wealth-building and community ownership.

The sustainability project component incorporates 1.5 acres of new, publicly accessible, open space, an all-electric building, roof-top solar panels, advanced storm-water resiliency systems, a transitoriented development, anticipated LEED Gold Standard, and an energy efficient, greenhouse gas-reducing design.

As reported, Manhattan-based Agallas Equities, which lost its bid to redevelop the Armory, has since filed a lawsuit against EDC, 8th Regiment Partners, and various current and former politicians and City officials, broadly alleging "a troubling pattern of political interference, procedural violations, and apparent intellectual property theft that [allegedly] corrupted what should have been a fair and transparent [RFP] public process."

The named parties deny any wrongdoing and the case is ongoing. Norwood News reached out to Taveras for comment on the latest joint partnership. We did not receive a response.

During the public hearing, attendees were appreciative, hopeful yet firm about their expectations, especially around employment. In response to the presentation by EDC at the hearing on contracting workers for the project, one union member said, "I understand you're using the name 'Local 79,' which is one [union] but you still got plumbers, you got fitters, you got painters, glaciers. There's other unions besides Local 79, so what I'm trying to make sure is that, yes, there's a lot of residential [work] that has not been union, but there's many that has been union. So, if you want to make it happen, you can make it happen." A hearty applause followed his testimony.

Norwood News asked EDC whether the PLA covers both Phase I and Phase II of the project and were informed that EDC signed a Letter of Intent with the Building Construction Trades Council (BCTC) to enter good faith negotiations for a PLA for Phase I of construction. EDC said 8th Regiment Partners agreed to participate in the PLA for the redevelopment of the Armory drill hall building (Phase I).

Additionally, EDC said that the project, from construction through operation, will be subject to New York City's "Community Hiring" program similar to "HireNYC," a free program run by EDC delivering "job-ready, qualified New Yorkers" to development projects, "while creating local employment opportunities for low-income New Yorkers."

EDC added that while the housing component (Phase II) does not have a PLA, 8th Regiment Partners committed to working with 32BJ for building service workers for both phases and the development team also agreed to work with Laborers Local 79 for Phase II construction. 8th Regiment Partners aims to break ground in 2026.

Another hearing attendee who gave testimony is a director and secretary of the Bronx Basketball Hall of Fame non-profit, the aim of which is to preserve "the rich heritage of basketball in The Bronx and those individuals whose extraordinary, skillful performances in turn inspire so many."

"Many people don't know... They'll realize that probably there are more professional basketball players, coaches, teachers, referees from this county than from any county in the United States in the NBA and in professional leagues and colleges all over the world," the man said.

He talked about preserving the borough's basketball legacy, teaching youth, and encouraging their dreams and desires to succeed. He said similarly De-

Witt Clinton High School had sent the most players from any U.S. high school to the professional basketball leagues. "We're looking to hopefully have a space in the armory [..] to continue our efforts not only in basketball, but we have like a Big Brother / Big Sister [mentoring] program," he said.

He added that the nonprofit is in contact with the Bronx Museum and Bronx Historical Society in order to showcase this rich Bronx basketball legacy. He said the group has also set up scholarship programs for Bronx youth. "I echo the sentiments of everybody that has spoken before, and hoping that they'll find a place for a community nonprofit corporation such as ours," he said.

Daniel Ranells of the Bronx River Alliance also gave testimony. "We have to upkeep the environmental standards during construction, after construction, and also in the lived environment," he said. "We don't want flooding. We don't want too much heat. We grew up in New York City, we're used to it being hot in the street."

He continued, "It doesn't always have to be that way. So, I ask the developers and the City to work with agencies to expand our green infrastructure, to expand our trees around the entire area, and to make it livable... a nice walk around the reservoir, walk around the armory. As we take care of our lived environment, we also need to take care of our community members, so I'm a strong advocate for having community hiring, having living wages."

The project is now moving at lightning speed. We will share more details of the public hearing in a follow-up story, along with details of 8th Regiment Partners' presentation at Bronx Community Board 7's land use committee meeting held June 10.

For her part, Sanchez said the joint partnership reflects the values and priorities laid out in the 'Together for Kingsbridge' Community Vision Plan which called for a project that delivered good-paying union jobs, space for youth and families, and economic development rooted in local neighborhoods.

She committed to evaluating the proposal as it moves through ULURP "with the rigor it deserves, guided by the Vision Plan." She added, "This is our once-in-ageneration chance to get this right, and we must."


